Morris hopes this will eliminate any misconseption of West Chicago's lack of quality education. "This recognizes that our educational system is exceptional," Morris stated.

It's about time we showed it's true colors to those who felt West Chicago was a worthless school. West Chicago has proven above everyone's expectations on what we can achive. Let's keep up our momentum and go beyond what they think.

# **Brown's Butchery**

Mass slaying in Palatine: What used to be a quiet town is no longer! Sometime between 9 p.m. on Friday and 3 a.m. Saturday morning seven people were tragically slaughtered.

The two owners, Richard and Lynn Ehlenfeldt were found dead in one cooler and the five other victims, Marcus Nellsen, Rico Solis, Michael Castro, Thomas Mennes, and Guadelupe Maldonado were found stashed in the other cooler.

Police say that Mrs. Ehlenfeldt was stabbed once in the neck and then shot in the head. Mr. Ehlenfeldt and Nellsen too, were shot in the head. The remaining victims were each shot twice.

As of now, no one has been charged for the murders. "There is a killer on the loose," Cook County States Attorney Jack O'Malley told the Sun Times. Also, the motive for the slaying has not yet been determined.

Ever since that dreadful night, Palatine residents have been in a state of panic. Residents have taken extra precaution, such as locks on screen doors, dead bolts, and motion detection lights ion fear that they might be the next victims.

# What are the Students Rights?

Well the rumor about the para-pros going into junior hallway and ransacking the lockers is not true, according Mr. Highland.

Highland said, "None of this is true. The only reason we would do this is to get textbooks from a students locker after withdrawal from school."

The students who thought this occurred were angry. As one student stated, "They have no right going through our stuff without us being there. This is a bunch of crap."

One student who wishes to remain anonymous stated, "The day this happened, I went to my locker and I saw some para-pros going through lockers and so I just went into my locker an took my jacket because there were cigarettes in my jacket. One of the parapros asked me if they could see my jacket and I said no and I walked away."

A para-pro, who wishes to remain anonymous, said, "We only search one locker if we have a probable cause. This rumor probably started because we look for calculators or anything stolen."

This may sound like invasion of privacy, but according to the law it is not. School officials need not obtain a warrant before searching a students, according to the <u>Illinois Law and Survey</u> 1990.

In a case, New Jersey vs. T.L.O. the law changed from "probable cause" to "probable suspicion" before searching a locker.

If school officials inform students that lockers are school district property for the student's convenience, and if the school officials warn students before the search, lockers may be searched if school officials have a probable cause.

If police officials are involved with the school officials for the search, a search warrant may be required under certain circumstances.

Police dogs are legal but may not be used for generalized searches.

A police officer is allowed to arrest a student on school property during the school day when the officer has a warrant.

# **Killer Kids and Baby Butchers**

In November 1992, in San Jose, Calif. three teens, ages 18, 16 and 15 went to the house where 8-year-old, Melvin was home alone sick from school when his brother's friends stopped by.

Melvin let them in when they told him that his older brother had run away and they needed to get clothes for him.

They took him to an upstairs bedroom, beat him, then stabbed him with a butcher knife. He didn't die. While they were there they stuffed a sock in his mouth and wrapped tape around his head.

Before they left one boy took a meat cleaver and hacked at Melvin's throat. His attackers left with a handheld video game and a portable television.

At 3:30 his 14-year-old brother came home to find him with his eyes wide open, brown plastic tape wrapped over his mouth, and a cord twisted around his neck.

Every year at least 1,000 to 1,500 American kids under the age of eighteen intentionally kill others and are arrested for murder or manslaughter. Some killings are motivated by greed, lust, or a desire for revenge. Others are crimes of passion and some are senseless.

What type of kids kill? They are a rare breed. Some of the kids are emotionally disturbed, mentally ill, mentally retarded, learning disabled, behaviorally disturbed, or simply "normal" kids who commit very abnormal acts.

The types of killings vary. There are family killings, theft- related, sexual, senseless, cult-related, crazy, gang, little kids who kill, and girls who kill.

In 1988 there were 16,326 murder and intentional manslaughter arrests in the United States. Only 1,765 of those were under eighteen years old. Even though that is only 11 percent of all murders, that is 11 percent too much.

In Chicago, through November 133 teens ages thirteen to seventeen were arrested for murders.

One example of a family killing took place on June 25, 1988. William Shrubsall was supposed to speak as class valedictorian at his high school graduation in Niagara Falls, New York. He beat his mother to death with a baseball bat after a lifetime of psychological abuse and occasional physical abuse.

Since he was young, she pushed him to achieve and he did. He was first in his class throughout school and number one in his high school graduating class of 250. But nothing he did made her happy.

That night, his mother who weighed 100 pounds more than him, abused him verbally and physically, threated to kill him and backed him into a corner in his bedroom. In self-defense, he picked up a baseball bat and beat her to death.

An example of a crazy killing is when a seventeen year old high school senior, Brenda Spencer, randomly fired a semi-automatic rifle into a crowded elementary schoolyard.

She killed the school's principle and a janitor who tried to shield the children. Eight kids and a police officer were wounded. When she was asked why she did it, she told them,"I don't like Mondays. Mondays always get me down."

In January 1989, two brothers ages four and six, from Missouri, attacked a twenty-month-old girl with a shovel, screwdriver, hammer, and brick because they thought she was "ugly" and because they "didn't like her."

In a cult-related killing, two thirteen year-old girls acted out a suicide pact on Election Day 1988. Marsh Urevich shot Nichole Eisel and then herself.

Even though both girls had troubled backgrounds, their deaths were partially because of a fascination in Satanism. They were known to be obsessed with the occult. In the weeks before they died, they told close friends of their suicide pact and their desire to "meet Satan."

Signs of children who are likely to kill are if they show no emotion and have a constant blank stare.

Psychologists have found that most killer kids come from abusive families, have troubled backgrounds, and they have not learned that it is acceptable to feel anger but not act on that anger. In the Chicago Tribune, a proposed solution is to prevent child abuse and create less-violent neighborhoods.

Then, later on, in the 1950's, blacks slowly started standing up for their rights. But what happened when a black person spoke his or her mind? They'd get beat up or even sometimes thrown in jail. Martin Luther King changed all of this in the late 1950's because he didn't give up. He was at many times thrown in jail and beat up but he still stood up for black's rights. There was a black man in the early slave days who lived in New York with his wife and two daughters. He was an excellent violin player who played for people in public and made a lot of money. Two white men came to one of his performances one night and offered him a violin job, making twice the money in California. They offered him to take the train with them that night to check it out and see where they would live and where he'd

it's not just another day off of school or work. People don't often realize what this man did for our country and how he totally changed black history. Could you imagine what it would be like to be a black man or woman to have lived one hundred years ago? Think about what we've studied in American History classes about the slaves and how they were treated. Think about the innocent blacks who were beat and whipped practically to death for taking a short break from their work, or stealing a piece of bread to hold them over until it was time for their small, disgusting meals.

Blacks back then did not get any opportunities to learn to read, write, or get any jobs besides being slaves. When the trip was over, the black man questioned the whites about where they were. They answered Georgia. The black man asked why and they admitted to him that they were slave catchers and he was now entering a new life, with a new name, a new, sloppy place to live, and a new white family that he was going to be picking cotton for everyday. He had no way of seeing his family again or live his dreams of being a professional violin player.

He missed his family so much that many times he tried escaping during the night, but always got caught. His punishments were to be severely whipped until he wasn't able to move off the cold ground. One time he tried to run away and got his feet sliced

#### Spin Doctors-Pocketful of Kryptonite \*\*

The Spin Doctors are part of a new music revolution. Though some people consider them alternative, the band is much more jam-oriented like the Blues Traveler, the Allman Brothers band, and the Grateful Dead. But unlike those bands, these guys make a definite attempt to make a variety of different songs, and sometimes it works.

Little Miss Can't Be Wrong is a great pop song with a sadistic edge, and it's getting some much deserved airplay on some of the local radio stations. Jimmy Olsen's Blues, Two Princes and More Than She Knows are jams, reminiscent of Earth rattling Grateful Dead songs like Shakedown Street and Touch of Gray, and How Could You Want Him is a song that echoes Led Zeppelin's Over The Hills and Far Away.

Unfortunately, the rest of the album is garbage. Refrigerator Car and What Time Is It? are blandly mediocre, and Forty or Fifty is just plain terrible.

The album has already made Platinum status (Over 1,000,000 copies sold), and is quickly climbing the Billboard Hot 100.

#### Spin Doctors-<u>Homebelly Groove...Live!</u> \*\*\*

The Spin Doctors also released a live album after all the fuss about *Little Miss* Can't Be Wrong. This album is basically just a re-release of their first EP, <u>Up For</u> <u>Grabs...Live!</u>, with lots of unreleased live gems.

The shining moment on this album is a little ditty called *Stepped on a Crack*, a bit of Jethro Tull wannabe-ism, complete with a flute solo. Other good songs include *Yo Mamas A Pajama*, and slightly reworked and quite enjoyable version of *Hard to Exist*. The rest of the album is just as good, with the only downers being the songs that were pretty crummy on <u>Pocketful of Kryptonite</u>.

Mary's Danish-American Standard \*\*\*

Mary's Danish is another new band trying to make an old sort of Rock 'n' Roll. Most of their songs sound like they went to the Jimi Hendrix School of Ear piercing feedback, though the music is much less Blues influenced than in Jimi's day.

Porcupine and Shotgun put new twists on their 60's style of power chord drenched music, and a sloppy cover of the 60's hit I Fought the Law is also very entertaining.

Not all of these songs are a 1967 renaissance, though. Killjoy and Underwater are cutting edge Alternative, and Sister Shade is pshycadelically tinged grunge rock.

There are very few things to gripe about on this album, and even the worst songs on the album are listenable. *Leave it Alone* is so distortion drenched that you can barely make out what they're saying, and *O*, *Lonely Soul*, *It's a Hard Road* is so out of place that you'd hardly think you were listening to the same band.

This album has barely made a ripple in the sales category, but is getting some airplay on the local Alternative stations.

#### Disney Gets Its Wish With Aladdin by Carolyn Mertz

Disney continued its string of hits in the new release Aladdin.

Aladdin is a combination of adventure, romance and comedy. The result is an entertaining movie for people of all ages.

The animation was colorful and imaginative. It was set in the Middle East, which made the film different and more interesting than the typical cartoon, despite the All-American voices. The musical score was fun and geared toward adults as well as children, although the song "A Whole New World" bore a striking resemblance to "Part of Your World" from <u>The Little Mermaid</u>.

Make an outline. It doesn't need to be formal or fancy. A simple list of abreviated words will do. Make sure you include everything you need and want to say.

The main characters included Aladdin, the poor village boy (with the voice of Scott Weinger of the TV show Full House) who falls in love with the over-protected Princess Jasmine.

The highlight of the movie was Robin Williams' hilarious portrayal of the Genie. From the moment Aladdin rubbed the magic lamp, Williams' impersonations (in a role practically written for him) made the film fun. The Genie also sang one of the best songs in the movie, "Prince Ali Ababa", when he gave Aladdin a parade that granted him his wish of being a prince.

Another amusing character was the parrot of Jafar, the traditionally evil and sinister character, in the humorously irritating voice of comedian Gilbert Gottfried. While the movie is predictable and in the usual Disney storyline of good vs. evil, Aladdin was a fun and entertaining movie.

One word of caution: you'll have to put up with hundreds of small children and bubble gum stuck to the seats, but it's worth it.

#### Only the Basics By Dina Bascharon

At West Chicago High School, besides the classes required to take for graduation, the selection of courses is limited to the very basics.

Assistant Principal, John Highland, said one of the reasons why We-Go's curriculum selection is limited is because the number of students enrolling in elective and Advanced Placement(AP) classes is few.

Currently, there are only four AP courses; AP English III and IV, AP Chemistry, and AP Calculas.

However, many neighboring schools have the same amount of enrollment in AP and elective classes, yet they also have a variety to choose from.

The variety includes AP Biology, AP History, AP Foreign Language classes, Anatomy, etc., plus the courses We-Go offers.

Recently, adding AP Biology to the science curriculum was brought before Superintendent, Dr. Morris.

Mrs. Tunt, the Head of the Science Department, claimed there were a few requirements to be agreed upon before AP Biology could become a class.

One, the teacher wouldn't be given adequate preparation for teaching the class. They would also need to have a 50% passing rate and everyone enrolled in the class must take the AP exam.

Having enough interest or enrollment in the class isn't stopping AP Biology from becoming a class, it's the unreasonable requirements set on the teacher and class.

Tunt felt these requirements were unfair because if a teacher can't prepare for the class, then they wouldn't be adequately qualified to teach it.

And although a 50% passing rate isn't unreasonable, saying all students must take the AP exam was.

"Some people take AP classes for college credit, some take it because they're just interested in the course," said Tunt.

Thus, she believes it's unjust to say everyone must take the test, when everyone's motives for taking the class would be different.

It's also unfair because some people can't afford \$60 or so to take the test. Since Tunt couldn't agree to these

stipulations, and the Administration wouldn't compromise, AP Biology won't be added to the curriculum.

The Foreign Language Department also lacks in AP classes.

Many students in the forth/fifth year of a foreign language often take the AP exam for that language. However, these classes aren't AP courses, so when students desire to take the exam, they aren't adequately prepared for it. There still may be some hope for change however. the Horticulture classes might be changed to Botany, so they can be considered college courses.

# **Pros and Cons of Weighted GPA**

Colleges across the country are receiving applications from students with grade point averages above four(on a four point scale). Yes, actually above four!

The question is, how much better is this than a 4.0?

Students end up with these higher grades by getting extra grade points for taking advanced classes. Knowing this many students at our own school are discouraged by the fact that they don't get anything "extra" out of taking advanced classes.

When confronting Dr. Janes on to

the GPA for advanced classes, while the Naperville schools add .65 and Wheatons add .75.

When We-Go did have a weighted grading scale (from 1970 to 1975) we used a multipliers to weight the grades. This meant that a math grade which was normally worth 4 for an A may be multiplied by .75, .85, 1.00, 1.15, or 1.25 depending on the difficulty of the class.

Another "negative" of this scale was stressed by Dr. Jones, "Students will stay only within the weighted system."

He explained this by saying that

be weighted and how much they should be weighted, the teaching staff, student counsel, and administrative staff did an extensive study of grade weighting and recommend to the Board that the grade weighting system established in 1970 be abolished."

Probably the most startling fact I learned by doing this report is the fact that most colleges de-weight grades after they get them to see how the students compare to others. So, basically a weighted GPA does almost nothing to help college admission.

After reading these facts some might still wonder: if it is so bad, then

When confronting Dr. Jones as to why we don't have a weighted scale, he gave several valid reasons why this scale doesn't exist here at We-Go. He stressed differences in individual ability by stating," We shouldn't penalize people who don't have extra godgiven gifts."

He also admitted to the fact that he, along with many other administrators have no idea where the extra grade points come from. For example, the Glenbard schools add an extra .25 to students would not take art, music, drama, etc.because they would be worth "less" in the grading system. From this stems yet another prob-

lem, which classes should be weighted?

This problem was also brought up in a report done by former superintendent Richard M. Kamm on December 22, 1987. The report stated...

"In 1974-75, after five years of wrangling within and between departments over which course should why do so many schools keep this system?

The answer is politics. Very few administrators agree with the system, but they don't want to deal with parents if they abolish it.

The facts are clear, as much as many of us hate to see them, that a weighted grading scale just isn't worth all the negatives it brings about.


#### Tough Expectations by Richie Fikis
